This year the school district is asking patrons to renew the existing plant facility levy that was first approved back in 1985. This levy has been at the \$400,000 per year, for a five year period, since 2006. The school district is asking to renew this levy with a 5% increase or \$20,000 per year, to cover the increasing cost of construction and school projects.

Why are we asking the community to renew this levy? The state of Idaho does not fund school facilities, (except for Lottery funds), so the local community bears that responsibility through bonds and levies. Bonds are used for large projects and new school construction, while a levy is used for smaller projects and ongoing maintenance needs.

Some of the recently completed school projects paid from the plant facility levy include:

Paving the 5<sup>th</sup> East road and pathway between the middle school and high school

Expanding the front parking lot of the high school

Upgrading the heating systems from coal to propane at Rendezvous, Tetonia & Victor schools

Purchasing a new school bus each year (the state depreciation funding would provide one new bus every 2-3 years)

Adding a modular classroom to Rendezvous, and remodeling space at Driggs elementary to create more learning areas

Future projects needed from plant facility funds include:

Roof repair at Driggs, Tetonia, Victor Elementary schools and Teton High School

Paving the bus areas at Driggs and Rendezvous schools

Upgrading the technology infrastructure and devices in all schools

Purchasing new school buses
